Project Location (describe, and attach a location map): Numerous parcels along NYS Route 22, Town of Pawling, Dutchess County. See HB (Highway Business) zone, in blue, on Zoning Map							
Brief Description of Proposed Action: Amendment to the Code of the Town of Pawling, Chapter 215 Zoning, section 215-28 to regulate how Gas Filling Station, Commercial Garages and Convenience Stores are developed on sites where they are already permitted by existing zoning. The local law does not involve any change to the uses permitted in the HB district, as gasoline filling stations, commercial garages and retail (food, grocery and general merchandise) stores are permitted uses in the HB zone. Changes to the supplementary requirements and standards for these uses would more clearly define the layout of these uses and add standards for screening, landscaping and development near the community's historic and scenic resources. The proposed action would be the adoption of the local law, yet would not involve any disturbance or development on any site. After adoption, development of these use would be required to comply with the amended zoning provisions. Refer to proposed local law.
