TOWN BOARD DISCUSSION

MCCARTHY

Councilman McCarthy said he sent the full board a bid packet for the bathrooms and boathouse at Lakeside Park. He asked them to look over the packet. There will be some changes to the documents over the next couple of weeks.

Councilman Mygan asked about executive session and asked if the meeting is adjourned before executive session, or is the meeting supposed to stay open during executive session and close the meeting when the board comes out of executive session.

Nancy Tagliafierro, town attorney said the board is not technically closing the meeting at that point. Someone makes a motion to go into executive session, but the meeting itself stays open, and then the board comes back out and closes the meeting formally. The board is not adjourning the meeting, they are just making a motion to go into executive session. She felt the adjournment item should come after executive session on the agenda.

SCHMITT

Supervisor Schmitt said the town board will be heading down to New York this weekend to the Association of Towns training. Every town is New York State is invited and there are many classes offered. It is a very informative and productive training.
