Supervisor James Schmitt opened the regular meeting of the town board of the Town of Pawling at 6:00 PM October 4, 2023, 2023 at Pawling Town Hall, 160 Charles Colman Blvd., Pawling, New York. Present were councilwomen Snow and Pitt, councilmen McCarthy and DeRosa, Nancy Tagliafierro, town attorney, and approximately 15 interested citizens.

Supervisor Schmitt said the community lost a young man named George Guerro, who was seventeen years old, in a tragic car accident, and he asked for a moment of silence to remember him.

MINUTES

Supervisor Schmitt made a motion to acknowledge the minutes of September 13, 2023, seconded by Councilwoman Snow, and passed unanimously.

Supervisor Schmitt made a motion to acknowledge the minutes of September 22, 2023, seconded by Councilman McCarthy, and passed unanimously.

PUBLIC COMMENT ON AGENDA ITEMS

Harvey Matcovsky, resident of Holmes, thanked the bookkeeper for presenting the budget. He said that the tax cap of 2% is imposed by New York State, with the possibility of increases over the 2% due to certain adjustments. The school board has not taken advantage of the adjustments and kept the tax levy well below the maximum allowed by law. The way out of the dilemma of increased taxes is to increase the tax base. The current town board has allowed two large developments, Castagna and the ASPCA, to use their tax exempt status to avoid the payment of a PILOT (payment in lieu of taxes), which in the past has been negotiated by the town. Both projects will use ambulance and fire services, along with other services that all other taxpayers in the town are paying for. He felt they should pay their fair share of taxes, and the town board should negotiate a PILOT so that these projects pay their fair share.

BUDGET PRESENTATION

Christine Mitchell, town bookkeeper, presented the 2024 tentative budget and a budget summary, which would be put on line so everyone could see them. She presented the 2024 budget summary as follows, asking the board to revisit the percentages for elected officials and discuss it further because the allocation skews the percentages:

THE LAKESIDE DEBT QUESTION

We paid off \$570,650 of Lakeside Park (A Fund) debt in 2023. What are we doing with the savings? \$305,298 was used to reduce the use of Fund Balance (savings). Pawling appropriated \$462,888 in 2023. We are appropriating \$157,590 in 2024. We appropriated a larger FB in prior years to keep the tax increase low:

All while absorbing a major increase in the cost of ambulance service

The remainder of the debt payment was used to reduce spending. Total A Fund spending for 2023 was budgeted at \$5,154,645. 2024 is budgeted at \$4,828,060. This is a \$326,585 spending reduction, a large part from having paid off the Lakeside Bond. Townwide taxes this year have a 1.02 DECREASE 5.85/1,000 vs 5.91/1,000.

PERSONNEL CONTINUED

The Town has \$48,000 of this savings budgeted for the employee Health Reimbursement Account in 2024.

She understood others may want to wait until next week to discuss this.

Supervisor Schmitt thanked Ms. Mitchell for her work on the budget.

TOWN BOARD DISCUSSION

PITT

Councilwoman Pitt said the town's town wide speed limit request has been accepted by the State and they will begin their investigation and study. Upon completion of the study, the town will be notified of their findings and conclusions. She said a ticket has been created northbound/southbound at Route 22 and Quaker due to the alignment of the lights. She would like to see toboggan run open again. The new website is on the way, she is in touch with the county on a daily basis. She has touched base with the historical society regarding replacing the historical markers around town. She asked if anyone had heard anything about a county wide ambulance service.

Supervisor Schmitt said no, nothing recently.

MCCARTHY

Councilman McCarthy said regarding next steps for "The Inn" project, there will be a meeting next week to discuss the bathrooms and pavilion.

SNOW

Councilwoman Snow said she was hoping to get someone to give the board a presentation on their experience with a conservation advisory board at an upcoming meeting.

DEROSA

Councilman DeRosa said the highway department is doing a good job on paving the roads at Sanita Hills. He asked about the bid for the PWD #2 water meters.

Supervisor Schmitt said the bid packet is being finalized by Laberge.

Councilman DeRosa said Whaley Lake is high, and Wendel Weber, supervisor of buildings and grounds is keeping an eye on the lake level. There are algae growing in the lake. What needs to be done is a study on the lake, and once that is done, recommendations can be made on how to correct the issues. He said the community group should take the samples and do the study. Councilman DeRosa said the number of transfer station permits being sold is going down every year, it is down to approximately 700 permits this year. Part of the capital fund is budgeted based on the number of permits sold, so the capital fund is lower. The board needs to look at doing something different there. Councilman DeRosa said regarding the health insurance buyout, he felt it should be based on a percentage, maybe 20% of the family plan, which would be calculated each year.

SCHMITT

Supervisor Schmitt said the board received a letter of resignation from the part time fire marshal. The town will be advertising for that position. He spoke to a number of residents on the height of Whaley Lake over the weekend. Mr. Weber and his crew are looking at the lake level. He said since June, there have been over thirty inches of rain.

Councilman DeRosa said the beaver dams in the swamp need to be taken care of. Supervisor Schmitt said he and Mr. Weber have been working on that.

PUBLIC COMMENT

Rick Wilson, resident from 64 Lakeview Drive, Whaley Lake said there are algae blooms in the lake, it is not the first time, and this is not the only lake that has them. He brought in samples to show the board the green water caused by the blooms. He said Whaley Lake is surrounded by three watersheds and he suggested the board research funding for this issue. There are solutions and with funding, it could be corrected.

Harvey Matcovsky, resident of Holmes, complimented Ms. Mitchell on the preparation of the budget. He is confident that she has taken into account Lakeside Park being paid off. There are increases that we have no control over, such as mortgage tax and the one solution is to increase the tax base. The town has large, wealthy institutions that refuse to pay their fair share. He has not heard a word from the board about the attempts being made to try to negotiate PILOT (payment in lieu of taxes) programs with these large projects.

Supervisor Schmitt said the town has not been asked for a PILOT program. If they want a PILOT program, they would have to ask for it.

Mr. Matcovsky asked what the board is doing to get these establishments to pay their fair share.

Janet Jones, resident from 5 Holiday Street, asked for an update on the Tremson project.

Supervisor Schmitt said they were issued a stop work order. There was a meeting to go over the fines they are facing at this time and the legal proceedings they are facing if they continue to violate the stop work order.

Marty Mygan, resident from One Aspen Court, said under personnel in the budget, it says most elected officials are getting a 2.75% allocation.

Supervisor Schmitt said the way it is currently set up is there was a total number taken and divided up between most elected officials, but it is open for change.

Mr. Mygan said regarding the health insurance buyout, he felt the \$4,500 was an extremely high amount. If you work for New York City, the health benefit buyout is \$1,000 for

family coverage and \$500.00 for a single. If you work for New York State, it is \$1,000 for individual and \$3,000 for family.

Supervisor Schmitt made a motion at 7:00 PM to adjourn the meeting and go into executive session to discuss personnel, seconded by councilwoman Pitt, motion passed unanimously.

The Board returned from executive session at 7:45 PM, no action was taken.
