Supervisor James Schmitt opened the regular meeting of the town board of the Town of Pawling at 6:00 PM July 12, 2023 at Pawling Town Hall, 160 Charles Colman Blvd., Pawling, New York. Present were councilwomen Snow and Pitt, councilman DeRosa, Nancy Tagliafierro, town attorney and approximately 25 interested citizens. Councilman McCarthy was absent.

MINUTES

Supervisor Schmitt made a motion to acknowledge the minutes of June 14, 2023, seconded by Councilwoman Snow motion passed unanimously.

PUBLIC HEARING & ADOPTION OF WATER DISTRICT NO. 2 IMPROVEMENTS \$750,000 BORROWING

Supervisor Schmitt made a motion to open the public hearing, seconded by Councilwoman Pitt, motion passed unanimously.

Harvey Matcovsky, resident of Holmes, said Pawling water district #2 is a mess. It has been neglected for years. A substantial amount of taxpayer money has gone to make some temporary repairs. If the bonds are issued, he as a taxpayer has little assurance or confidence that this will finally solve the problems. The people in the district will actually be paying the interest and maintenance of these bonds, he wanted to make that clear, there are only sixty people in the district. This will be a lot of money for the residents in the district.

Supervisor Schmitt said this board has made substantial headway with the district recently, and the roads are being paved in that area.

Councilman DeRosa said the town may have to replace the storage tanks per the health department. This may not be the only bond depending on what other improvements the Dutchess County Board of Health will mandate for the water system.

Supervisor Schmitt said before any of the money is spent, there will be a resolution and it will be spoken about at a town board meeting. The town will also be applying for grant funding for all parts of this project.

Mr. Matcovsky asked if the town has tried to minimize the impact to residents and consulted with the Dutchess County Water Wastewater Authority.

Supervisor Schmitt said yes, the board consults with the health department and prioritizes what they want to see upgraded and repaired in the district. The health department has been involved from the beginning and they oversee all private districts.

Mr. Matcovsky asked for documentation that the board has consulted with the county and what they have done.

Supervisor Schmitt said the health department are the entity requiring the updates to PWD #2.

Mr. Matcovsky said he hoped that the town board makes sure that the people in the Shorehaven water district are not overpaying.

Supervisor Schmitt said Mr. Matcovsky should speak with county legislator Ed Hauser regarding the Shorehaven water district, the Town of Pawling has nothing to do with that district.

Mr. Matcovsky said he had a problem with putting an excessive debt burden on the sixty members of PWD #2. He is fearful that at some point, the obligations will be shifted onto the taxpayers of the Town of Pawling.

Supervisor Schmitt said private district money cannot be shifted onto the taxpayers. The board applies for grants for all of these projects. This will be a very thorough process. Clean healthy water is important.

There were no more comments from the audience.

Supervisor Schmitt made a motion to close the public hearing, seconded by Councilman DeRosa, motion passed unanimously.

A Resolution Authorizing the Issuance of \$750,000 Bonds of the Town of Pawling to Pay the Cost of the Increase and Improvement of the Facilities of Water District No. 2

WHEREAS, pursuant to the provisions heretofore duly had and taken in accordance with the provisions of Section 202-b of the Town Law, and more particularly an Order dated the date hereof, said Town Board has determined it to be in the public interest to improve the facilities of Water District No. 2, in the Town of Pawling, Dutchess County, New York, at a maximum estimated cost of \$750,000; and

WHEREAS, the capital project hereinafter described, as proposed, has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which regulations state that Type II Actions will not have any significant adverse impact on the environment; NOW, THEREFORE, BE IT

RESOLVED, by the Town Board of the Town of Pawling, Dutchess County, New York, as follows:

Section 1. For the class of objects or purposes of paying the cost of the increase and improvement of Water District No. 2, in the Town of Pawling, Dutchess County, New York, being costs related to connection to improvements to the existing water treatment plant, including an update of controls, piping, metering, backwash disposal, as well as actual building improvements, with all of this work anticipated to be within, on or adjacent to the existing building; improvements to existing water supply wells; installation of valves on existing water mains in the District; replacement of portions of the water distribution system in the same

location as existing; replacement of two 25,000 gallon finished water storage tanks with a single above ground, low-risk tank on the treatment plant property adjacent to the treatment building; and replacement individual water service meters, incidental improvements and expenses in connection therewith, there are hereby authorized to be issued \$750,000 bonds of said Town.

Section 2. It is hereby determined that the maximum estimated cost of the aforesaid class of objects or purposes is \$750,000, which class of objects or purposes is hereby authorized at said maximum estimated cost, and that the plan for the financing thereof is by the issuance of the \$750,000 bonds of said Town authorized to be issued pursuant to this bond resolution.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is forty years pursuant to subdivision 1 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

Section 4. The faith and credit of said Town of Pawling, Dutchess County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. To the extent not paid from monies raised from said Water District No. 2 as applicable in the manner provided by law, there shall annually be levied on all the taxable real property of said Town, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable; PROVIDED, HOWEVER, that to the extent that any grants-in-aid are received for such class of objects or purposes or the Town Board shall appropriate other monies of the Town

therefor, the amount of bonds to be issued pursuant to this resolution shall be reduced dollar for dollar.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

Section 6. The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Supervisor, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as he shall deem best for the interests of said Town, including, but not limited to, the power to sell said bonds to the New York State Environmental Facilities Corporation; provided, however, that in the exercise of these delegated powers, the Supervisor shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller applicable to the sale of municipal bonds. The receipt of the Supervisor shall be a full acquittance to the purchaser of such bonds, who shall not be obliged to see to the application of the purchase money.

Section 7. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Supervisor, the chief fiscal officer of such Town. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such for recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Supervisor shall determine consistent with the provisions of the Local Finance Law.

Section 8. The Supervisor is hereby further authorized, at his sole discretion, to execute a project finance and/or loan agreement, and any other agreements with the New York State Department of Health and/or the New York State Environmental Facilities Corporation, including amendments thereto, and including any instruments (or amendments thereto) in the effectuation thereof, in order to effect the financing or refinancing of the class of objects or purposes described in Section 1 hereof, or a portion thereof, by a bond, and/or note issue of said Town in the event of the sale of same to the New York State Environmental Facilities Corporation.

Section 9. The power to issue and sell notes to the New York State Environmental Facilities corporation pursuant to Section 169.00 of the Local Finance Law is hereby delegated to the Supervisor. Such notes shall be of such terms, form and contents as may be prescribed by said Supervisor consistent with the provisions of the Local Finance Law.

Section 10. The validity of such bonds and bond anticipation notes may be contested only if:

1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or

2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 11. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 12. This resolution, which takes effect immediately, shall be published in summary form in the official newspaper, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

RESOLUTION 2023-123

2023 AMENDMENT TO AGREEMENT OF MUNICIPAL COOPERATION FOR CONSTRUCTION, FINANCING AND OPERATION OF AN INTER-MUNICIPAL SEWER INTERCEPTOR, TREATMENT AND DISPOSAL SYSTEM

THIS AMENDMENT TO AGREEMENT is made this _____ day of __ , 2023 ("Effective Date"), by and between the Village of Pawling, Dutchess County, New York ("Village") and the Town of Pawling, Dutchess County, New York ("Town")

WITNESSETH:

WHEREAS, the Village and Town entered into an Agreement of Municipal Cooperation for Construction, Financing and Operation of an Inter-Municipal Sewer Interceptor Treatment and Disposal System ("Agreement") dated February 16, 1983; and

WHEREAS, the Agreement was amended by amendments dated October 19, 1985, February 20, 1986, January 11, 1994 (which voided a July 12, 1991 amendment), October 12, 1999, July 28, 2014, December 14, 2017 and February 20, 2018, and

WHEREAS, the Parties wish to further amend the agreement as provided below;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. Definitions. Except as otherwise expressly defined in this amendment, each capitalized term which is used in this amendment and defined in the Original Agreement shall have the meaning set forth in the Original Agreement. The following terms shall have the meaning ascribed to such term herein:
 - "Effective Date" shall have the meaning set forth in the first paragraph of this 1.1 amendment.
 - "Original Agreement" means the Original Agreement as amended by amendments 1.2 dated October 29, 1985; February 20, 1986; January 11, 1994 (which voided a

July 12, 1991 amendment); October 12, 1999; July 28, 2014; December 14, 2017 and February 20, 2018.

2. The first full paragraph of Section 1 of the Original Agreement is deleted and the following is inserted in its place:

"1. Creation of Commission. The Commission shall consist of seven (7) members, five (5) members consisting of the Mayor and the four (4) members of the Village of Pawling Board of Trustees ("Village Commissioners") and two (2) members from the Town of Pawling to be appointed by the Town Supervisor of the Town of Pawling ("Town Commissioners"). The Town Supervisor may appoint an alternate Commissioner ("Alternate Commissioner"). Whenever either one of the Town Commissioners is unable to attend a meeting of the Commission, the Alternate Commissioner may attend such meeting in place of such absent Town Commissioner and at that meeting that Alternate Commissioner shall have the same powers, duties and responsibilities as the absent Town Commissioner, including without limitation to power to vote on any matter presented to the Commissioners at such meeting. For the sake of clarification, in the event that both Town Commissioners are unable to attend a given meeting of the Commission and the Alternative Commissioner attends such meeting, the Alternate Commissioner shall only have one (1) vote at such meeting. Voting by proxy shall not be permitted. The Commission shall meet annually on the 2nd Thursday in April at 7:00 PM at the Village offices for the annual reorganization meeting. At such annual meeting, the Commission shall elect its own chairman, vice-chairman, secretary and treasurer and shall establish the time and place of regular meetings of the Commission. Robert's Rules of Order will apply to the conduct of all meetings."

The balance of paragraph 1 of the Original Agreement shall remain as originally written.

- 3. The Parties hereto represent and warrant: (a) that this amendment has been presented to the governing bodies of such Party; (b) that such governing body has approved this amendment by a majority vote of the entire voting strength of its governing body; and (c) that the Original Agreement as amended by this amendment is the valid and legally binding obligation of such Party and is enforceable in accord with its terms except as enforcement may be limited by bankruptcy, insolvency, reorganization or other laws relating to the enforcement of creditors' rights generally and by the discretionary nature of equitable remedies.
- 4. The Original Agreement as amended by this amendment is hereby ratified and confirmed and shall remain in full force and effect in accord with its terms.
- 5. This amendment is effective on the Effective Date.

DISCUSSION

THANK YOU TO CHIEF WHITE AND THE PAWLING FIRE DEPARTMENT

Councilman DeRosa thanked Fire Chief Everett White, and the fire department, Bob Brill, highway superintendent and the highway guys, Wendel Weber, supervisor of buildings & grounds and his maintenance guys, and Tom Basile, the building inspector for all of their work during the storm and after. The town is quite a mess and he did not know where the town would find the money to fix all of the roads, which are devastated. It was a terrible storm, with nine inches of rain falling in twenty four hours. The supervisor has been involved with politicians and the county to try to get funds to help with the damage. Councilman DeRosa said the Whaley Lake dam held well during the storm.

Councilwoman Snow echoed councilman DeRosa's comments, and she thanked everyone for helping and continuing to do what they could for the community. Councilwoman Snow said the Pawling rotary was honored for their outstanding service and they received an award, relating to the naturalization ceremony.

Councilwoman Pitt echoed councilman DeRosa's and councilwoman Snow's comments, saying the storm was severe and it was the worst devastating damage she has seen in local townships in her twenty plus years of service. She thanked the men and women of the Pawling volunteer fire department, the men, women of law enforcement, and men and women of the highway department.

Supervisor Schmitt said he has been of the phone with elected officials to try to get help with the damage from the storm. He will be touring the damage with these officials to try to get financial help. Letter's of support have been sent up to the governor's office and he said there is a threshold that would have to be met before FEMA would get involved.

PUBLIC COMMENT

Nicholas Cienti, resident from 29 Old Route 55, said his access bridge was completely washed away in the storm so his cars are stranded. The community was really helpful during the storm, and he was grateful for that. He thanked the board for some of the information on FEMA. He understood there was not a lot the town could do in a situation like this. He asked what the board would suggest as next steps. He has filed his claim to repair the bridge. He asked that the board keep him informed on a time frame for the repair of Old Route 55. He wasn't sure how to proceed. He heard from the neighbors that there were some things that could have helped prevent this, such as keeping tree trimmings clear from the road side, reinforcement at certain parts of the stream and sufficient drainage for the pond along Old Route 55, which always floods.

Bob Brill, highway superintendent, said a lot of roads have been closed, and some have been reopened already. Old Route 55 is still closed from Dodge Road into the village because of major washouts. He is working on rebuilding and reopening the roads. River Road is also closed but the dump can be accessed from Route 22. Bundy Hill is still in very bad shape but they are working on that road. The tree debris Mr. Cienti is speaking about is typically what the power company trims. When he trims trees, they are chipped and removed, never left there. He said Old Route 55 is in terrible condition and it will cost a lot of money to rehabilitate. The entire road needs to be redone. He said all roads need work and it will cost hundreds of thousands of dollars to repair/redo and it will take months. Over the past couple of days, his concern was to open the roads for emergency services to be able to get in, in case of an emergency and have residents be able to get in and out. In his entire life living here, he has never seen this kind of damage. This will completely change his scope of work in following the town's road plan, doing road work and paving, and what he had planned for the next several years. This completely changes everything.

Ellen Meagher, resident from 15 Old Route 55, expressed concern about emergency services and school busses having access to Old Route 55. She said all workers were very nice and very professional.

Mr. Brill said he will have Old Route 55 passable within a couple of weeks. He will communicate with the school as to what the busses can do on a daily or weekly basis, whatever is necessary. He is also in contact, on a daily basis, with the fire chief and emergency services on what roads are open and closed and where they have to travel.

Mr. Cienti asked if the utility company could be fined for not cleaning up tree trimmings.

Supervisor Schmitt said the town could not fine them but he will discuss this with the politicians he meets with tomorrow.

Rick Wilson, resident from 64 Lakeview Drive, Whaley Lake, thanked Mr. Brill and Mr. Schmitt for all of the help they have given Shorehaven. They were very happy with the little bit of damage they got this storm, and feel bad for the people who did get a lot of damage. They are also appreciative of the one million dollar grant they received for the dam. He said there are seven major culverts that run into Shorehaven, along with the Grape Hollow Stream. He has spoken with a representative from senator Rob Rolison's office and asked that he come and look at these culverts, they are NYS's responsibility. He hoped someone could look at these seven culverts.

Supervisor Schmitt said he would be looking at the culverts tomorrow with the elected officials he would be meeting with.

Russell Smith, resident from 1544 Route 292, said he is not happy with the situation and he does not get responses from the town supervisor. Many neighbors have called and his wife wrote an email regarding the level of the lake to the board. The water runs off of Route 292 and right across his driveway. He spent \$7,200 a couple of weeks ago on landscaping, which was all washed away. He understood that this is a state road, but he is asking the town for help.

Supervisor Schmitt said Route 292 is a NYS road and this can be looked at tomorrow during the meeting with elected officials to assess the storm damage.

Pete Bissonette, resident from 1606 Route 292, Whaley Lake said there were errors when the dam was built. The things people are experiencing now lake residents are getting all of the time because of the errors in the dam. The dam was built too low and too narrow. Some residents have flooding now, which they never had before.

Supervisor Schmitt said the draw down valve was opened the day before the storm in preparation for the storm, and the lake was monitored during the storm. He said the engineers who designed this dam have assured the town that the spillway met all of the hydraulics studies necessary from NYS DEC to withstand a five hundred year storm. The town has people monitoring houses during this storm, and they did not take on water during this storm.

Mr. Bissonette said there should have been two spillways, because that would have been better.

Russell Smith presented photographs of his property to the board to show the damage. He felt the lake was too high. He read an email his wife, Daan Van Alderwerelt, wrote to the board on June 30, 2023 expressing concern about the high water level of the lake. The right of way across Route 292 needs to be addressed because the water flows right across his property.

Councilman DeRosa said when he was president of Shorehaven, he spoke to the engineers and warned them about the amount of water they were putting down on Shorehaven roads. The engineers argued and said they weren't adding any water to Shorehaven roads. It is New York State and Route 292 is a state road.

Paul Malichek, resident from 70 Lakeview Drive, Whaley Lake said the dam was 705.8 before any work was done. The spillway is not wide enough and it is not working properly. If the spillway was wide enough, this would not happen and the lake would not pool. The lake is going to be killed if this is not corrected. He has been coming up here over thirty years, and he has not seen this ever happen before. There is also green slime in the lake, which was never there before. They are asking the board to help them. It is well documented that the dam was at 705.8.

Joe Marotta, resident from 1680 Route 292, said pool level is 705.8. You cannot have a 704.8 spillway and a water level at 705.8. Everyone has seen the emails, Zarecki says in the emails they made a mistake, the height was a foot too low. The spillway needs to be wider, the old spillway was 28 feet wide, now the spillway is eighteen and a half feet wide and it is not

shedding the water quick enough and boards need to be taken on and off. It was never meant to have boards be taken on and off, and that is so stated in NYS DEC documentation. The valve should only be for emergencies. Taking boards in and out is a lot of human intervention. NYS DEC only cares that the dam will not break and flood anyone downhill. They don't care if people die taking the boards on and off. They don't care about the height. The dam is supposed to be at 705.7 or 705.8, that's the difference and the pool level at 705.8. No one ever got flooded before unless there was debris clogging the spillway. 705.8 is the solution. The water level affects algae and weeds and it could kill the lake. He suggested getting an engineer and professionals out to the lake.

Nancy Tagliafierro said that would cost everyone in the dam district money.

Supervisor Schmitt said this has gone on for many years and many professionals have been involved.

Rick Wilson, resident from 64 Lakeview Drive, Whaley Lake, said he has done a lot of research on this. From the 2000 and 2006 reports Zarecki put out, it states, "the invert of the spillway is at 704.8". But it references appendix B, which he FOILed and received, which had the 1999 survey, which stated very clearly 705.8 as the normal pond elevation. He has the 2009 Fuss & O'Neil engineering drawings stamped January 2009, with a professional engineer's report that 705.8 elevation with the spillway clearly there marked at 704.8 in 2009. The town's not responsible for those errors. The 705.8 normal pond elevation is correct. The 704.8 invert of the spillway in the 2000 and 2006 Zarecki report is wrong. They knew it was wrong and they were negligent because they should have known or they did know and went ahead anyway. There was an email including Dustin Winn from Winn Construction, Dave Kelly and Kevin Flood from Fuss & O'Neill on October 4, 2017 which states, "the spillway elevation on the plans 704.8 was off and is actually 705.8". He read the January 1985 guidelines for design of dam's New dams, which state that flash boards shall not be installed on any new dams. The dam owner shall determine the normal pool elevation for the proposed impoundment and provide a permanently fixed spillway crest at the selected elevation. There was a town meeting at the Whaley Lake Civic Center on September 14, 2019, where councilman Johnson stated, one of the gentlemen that was at the dam meeting from NYS DEC said that a possibility also exists to widen the initial spillway. There are a lot of options but a study would have to be done" This is documented in the Town of Pawling meeting minutes. Also, at the September 14, 2019 meeting, supervisor Schmitt said, "he has never seen the weir boards in any design plans. The way to do this is to pick an elevation and build the spillway to the right elevation. The draw down valve is to be able to lower the lake when you need to". He thanked the board for lowering the lake when they did before this storm. The board should consider what councilman Johnson and supervisor Schmitt discussed in 2019. The town board is the determining entity according to the DEC guidelines because the dam owner shall determine the normal pool elevation for the proposed impoundment and provide a permanently fixed spillway crest at the selected elevation. There were many professional engineers on this project since the 1990's and the NYS DEC was overseeing this. The town should consider what Mr. Bissonnette said, which is that this is bonded and these instances should be discussed with the professional engineers and the NYS DEC should be consulted. He has lived on the lake since 1986, and no one ever opened a valve, until now. He hoped the board would look into the facts and liability of this.

Russell Smith, resident from 1544 Route 292, Whaley Lake said his wife's parents bought the property 1968, and he felt the lake was better now. Previously there had been a lot of weeds and slime. If the lake is raised, it will affect his dock.

The motion to adjourn was made by supervisor Schmitt at 7:50 PM, seconded by councilman DeRosa, motion passed unanimously.
