SNOW

Councilwoman Snow announced that there are many events going on in the town. She said the Fayne Daniels walk so they may ride fundraiser for the Pawling Resource Center will take place this Saturday. This is one of their biggest fund raisers. Councilwoman Snow said the Rotary fall fest fundraiser is a week from Saturday, which is a free event for all families, and is their biggest fundraiser. She congratulated the Pawling library for being honored for the great stories club for under served teens. The library received two grants and will utilize those grants for teens.

MCARTHY

Councilman McCarthy said the board of health approved the current fields at the old Inn at Lakeside Park, which will save the town a lot of money. The only thing the town will need to do is put in a tank to pump up to the fields.

PITT

Councilwoman Pitt said she received confirmation from Dutchess County that they have received the necessary paperwork for the speed limit project, and have forwarded it to New York State. She will follow up on this in about a week. Councilwoman Pitt said at Lakeside Park, people have a difficult time putting their dogs on a leash and she suggested raising the fine for dogs not on a leash. She asked people to put their dogs on a leash. She would like to see toboggan run opened again, she thought that was awesome. She said the Dutchess County link for natural resources could be added to the new website.

Councilwoman Snow said legislative aide Stephanie Giordano did a lot of work on the new website and was a big help.

SCHMITT

Supervisor Schmitt said he spent time with highway superintendent Bob Brill in Holmes this week. The highway department is working hard on the roads in that area.

SET PUBLIC HEARING/SOLAR ENERGY LOCAL LAW

Following discussion, supervisor Schmitt made a motion to schedule the public hearing for the solar energy local law for November 1, 2023, seconded by councilman DeRosa, motion passed unanimously.

PUBLIC COMMENT

Harvey Matcovsky, resident of Holmes, said the Pawling resource center and Pawling rotary are the most worthy organizations supporting this community, and they both deserve the community's support. Mr. Matcovsky said Yom Kippur is the holiest day of the year for observant Jews. This year it falls on September 25th and he urged the town board to change the Pawling zoning board of appeals meeting scheduled for that date out of respect for the holiday. He also said he hoped there would be a public debate for the November election so that the public can question town board candidates on the many issues facing the town.

Marty Mygan, resident from one Aspen Court said he has brought up in the past that the elected town officials should be required to annually file a financial disclosure statement, that includes employment history, involvement in private or public organizations and other financial or business interests. There is no financial disclosure required in Pawling government. He believed this should be required to give residents confidence in local government and he hoped the board would consider it.
