Supervisor James Schmitt opened the regular meeting of the town board of the Town of Pawling at 6:00 PM May 14, 2025 at Pawling Town Hall, 160 Charles Colman Blvd., Pawling, New York. Present were councilwomen Snow and Pitt, councilmen Mygan and McCarthy, Nancy Tagliafierro, town attorney, and approximately 10 interested citizens.

PRESENTATION/CONSERVATION ADVISORY BOARD

The board entertained a presentation by members of the Conservation Advisory Board (CAB). Robert Bergdall, chairperson of the CAB, discussed the current activities of the reconstituted board. He explained when the CAB was formed in 1967 and was a committee and became a board in 1977. The function of the CAB is to advise the town board and planning board on a wide range of ecological issues in the town, and educate the public. He talked about the tasks each CAB member is currently working on, and that they hope to accomplish a town wide Natural Resource Inventory. The CAB is happy to help in any way they can.

Mark Chipkin thanked the board for reconstituting the CAB, and said they would first need to identify Pawling's natural resources, and put them in priority order. He discussed the value of protecting open space and creating an open space plan to protect and manage those resources now and for the future. He explained the benefits of open space, namely the protection of water quality, flood control and protecting wetlands. He talked about the tree planting project and the benefits of planting the trees, namely reducing carbon dioxide and emissions and producing clean air. He felt plans to preserve all of the natural resources needed to be done. The CAB appreciates the town board, saying they have been nothing but supportive to the CAB, and he hoped the town board's support would continue. They want the town board to continue to support them and help them engage with community members and assist with town and village projects. Working together, and with the comprehensive plan, they hope to create and implement an open space plan that reflects the town board's and community's goals by balancing economic growth, environmental preservation and the needs of the current residents without compromising the natural resources we have available for future generations.

Steven DiFalco, CAB member talked about conservation planning, and he talked about conservation options, and how the town could protect natural resources. He described a natural resource inventory and what that would include, saying it would provide building blocks of comprehensive land use and conservation planning, and allow natural resource information to be included in local planning and zoning. They met with NYS DEC, specifically the Hudson Valley Estuary Program, to discuss the grant process that is overseen by NY DEC, and there are a lot of different options and guidance.

Following questions by the town board, they thanked Mr. Bergdall, Mr. Chipkin and Mr. DiFalco for the presentation.
