PITT

Councilwoman Pitt thanked the buildings and grounds, and highway departments for helping the Legion get the veterans banners up around town. She was happy the bathrooms at the boathouse are up and running before the park opens for the summer.

SNOW

Councilwoman Snow said since the last meeting, the board learned from their attorney that the full town board will be making the decision on the comprehensive plan committee members, not just the supervisor. Also, she called the Association of Towns to follow up on the fact that if there are three or more board members are on an email or text, it does constitute a quorum, and the emails/texts are then subject to FOIL. She has been visiting the dog park and she found a \$25,000.00 grant for upgrades to the dog park, which she will follow up on.

MYGAN

Councilman Mygan said there were a couple of meters there were problems with at PWD #2, and the board was talking about getting in the residences to fix them.

Supervisor Schmitt said three out of four residents did not reply to the water operator to have their meters checked/replaced, and he is working on a way to increase what they will be billed if they have a meter that is not reading properly, and they don't allow access for it to be repaired.

Councilman Mygan asked about the fees for solar, that was discussed last month.

Supervisor Schmitt said the building department is looking at the fees for that department and he hoped to have proposed changes to the building department fees for next month's meeting.

Councilman Mygan said regarding the community garden, the board approved it and signed the contract, and water was supposed to be supplied to them at their cost. He asked where that was at in the process.

Supervisor Schmitt said Wendel Weber, supervisor of buildings and grounds has said he would not be able to get to that for probably six weeks, as he is very busy. Supervisor Schmitt said he would try to get volunteers to get this done so the community garden doesn't have to wait six weeks for water.

Councilman Mygan felt the representatives of the community garden should be notified as to what is going on.

Supervisor Schmitt said next week, he will discuss replacing the highway superintendent's truck and giving his old truck to the building department. There is money in the highway fund for this truck. Supervisor Schmitt thanked Barbara Tyson, tax collector for helping a resident who contacted him with their tax bill. Supervisor Schmitt thanked Everett White, building inspector/fire chief for a wonderful job with the game dinner.
